## **DISCLOSURE PURSUANT TO ART. 13 OF LEGISLATIVE DECREE No. 196/2003 AND ART. 13 OF EU REGULATIONS No. 679/2016**

### **1. Introduction**

Pursuant to art. 13 of Legislative Decree No. 196/2003 ("*Personal data protection code*") and art. 13 of EU Regulations No. 679/2016 ("*General Data Protection Regulation*"), Hotel Pennile informs you that your personal data collected through your access to the Internet by means of the routers installed at the hotel are acquired in respect of the rights, freedoms, and dignity of the service user, with particular reference to privacy and personal identity and the right to the protection of personal data.

As a result, the hotel provides you with the information regarding the use of your personal data.

### **2. Source of personal data**

The collection of personal data takes place by recording your access to the Internet through the equipment owned by the Hotel Pennile.

### **3. Aims of the treatment**

Guests can surf the Internet through the infrastructure owned by the Hotel.

Therefore, personal data are processed and stored for administrative purposes (pursuant to national and local regulations), as well as for security purposes regarding the correct and lawful use of information and communication resources used while browsing the web.

### **4. Data treatment**

Your personal data are collected exclusively for the aforementioned purposes. The security and confidentiality of them are guaranteed.

In no event shall the Hotel sell the collected personal information to third parties.

Once the aforementioned purposes have been achieved, the data will be erased or made anonymous.

### **5. Optional provision of data**

Providing your data is optional, but failure to provide them results in denial of access to the Internet through the infrastructure owned by the Hotel. Since data collection is automatic, the only way to oppose this process is by immediately disconnecting from the Internet service provided by the Hotel.

Therefore, Hotel guests connecting to the Internet are made fully aware of this policy and show their conscious will to give their personal information for the above purposes.

## **6. Categories of subjects to whom the data may be communicated or who can learn about them**

Your personal information will only be seen by Mr. Marco Ciucci (*data processor*). Exclusively for the purposes set out in paragraph 3 ("*Aims of the treatment*"), your data may become available to third parties.

## **7. User rights**

We also inform you that the rules regarding the protection of personal data give interested parties the possibility of exercising certain rights under the provisions of the "*Personal data protection code*" and the "*General Data Protection Regulation*".

In particular, the persons to whom the personal data refer may obtain confirmation at any time whether those data exist or not and any information regarding their content and origin, verify that they are exact, or request that they be updated, modified, or corrected.

Furthermore, users have the right to request the deletion, transformation into anonymous form, or blocking of data processed in violation of the law, and the right to object to the use or processing of their personal data for the purposes of supplying advertising materials, or direct sales, or for the purposes of market research, or commercial communications.
